Christ Church Ashton Annual Vestry for 2019 Sunday Feb 23, 2020

- 1. The Rev. Canon Mary Ellen Berry opened the meeting with prayer with 31 people in attendance who signed the Vestry Book.
- 2. Appointment of Vestry Clerk: Michelle Kay
- 3. Approval of Agenda: Moved Henry Troup. Second Maggie Thorsell. Motion carried.
- 4. Approval of the Minutes from the 2018 Vestry Meeting held Mar 3, 2019. In the absence of errors, omission or amendments, Moved David Thorsell. Second Trilly McKenzie. Motion carried.
- 5. Approval of the collective Vestry Reports except for the 2019 financial report and the 2020 budget: Moved Ed Brigden. Second Janice Hansen. Motion carried. Comments or questions? Janice Hansen asked re: the furnace any thoughts on when replacement may be needed? David Thorsell responded we are limping along with what we have for now, but we do need to explore options this summer to be prepared for winter 2020-2021, the next heating season.
- 6. Presentation of 2019 financial report by Lois Lohmann
  - Page 28 Balance Sheet.
    - Finished 2019 with \$39,477 total in the 3 bank accounts.
    - Federal & Provincial Sales Tax Recoverable represent amounts for 2019 that get submitted quarterly in 2020. So the amounts reported as Federal & Provincial Sales Tax Rebate represent what was received in 2019 for 2018 rebates.
    - Consolidated Trust Funds new market values for Jan 2020 can be found on pg 50.
    - All liabilities were paid in 2019 including the PWRDF flow-through donations.
    - Unrestricted funds are the amounts that cover offerings, donations, dividends and expenses. Balances are brought forward each year + revenue received in the year expenses incurred in the year = Year End balance.
    - Permanently restricted funds are as detailed. Money is being put towards the large carry forward deficit as approved at last years budget in an effort to pay off the monies owing.
  - Pg 30 Income & Expenses. 2019 actual revenue & expenses vs budget were reviewed. Some variances are due to timing. Key total lines were highlighted. Initially there was a \$14,843 deficit reported at year end. After negotiation with the Diocese, Lois received a letter from the diocesan accounting office that resulted in the 2019 final balance owing

being reduced to zero. Congratulations Lois! As a result, a surplus of \$1,419 was realized.

- Pg 33 Receipts & Disbursements for flow through funds: PWRDF, Ashton Cemetery, Prospect Cemetery, Rector's Discretionary Fund, Transfers to VBS.
- Pg. 35 Outreach Fund Receipts & Disbursements highlighted. Question was asked why Center 454 had not cashed their cheques, but the answer is unknown. Barclay Frost so do we keep sending a cheque to Centre 454?
- Pg 27 Altar Guild Donations & Expenses Brian Hull Is the wine donated? Lois Lohmann No, the altar guild pays for this.
- Pg 29 ACW Income & Expenses. Closing balance was transferred to CCA effective June 6, 2019 so that ACW funds are now handled within the overall church funds and not independently.
- Pg 41 Major Maintenance Projects Receipts & Disbursements. \$15,000 was requested from the CTF to assist with the masonry/repointing projects in 2019. The balance left over will be put toward capital work that is needed on the kitchen in 2020. Money was also donated by the friends of St. Augustine. (Note: When we take money from the CTF it is to be used for capital purposes. This does not include snow removal or grass cutting. We have an exemption for this site that includes accessibility access. Capital expenditures allow us to claim exemptions at year end.)
- Pg 44 Ashton Cemetery Receipts & Disbursements. Due to timing on reporting, some information is not received in time for annual vestry reporting, particularly re: dividends. As a result, every year we seem to be behind.
- Pg 47 Prospect Church Cemetery Receipts & Disbursements. Again, there are issues with the timing of dividends. Linda Stanton please explain how the caretaking fee works? Barclay Frost caretaking is done by Lee Jones & sons and this is a blessing to us. They do this on an annual contract that is very reasonable.
  - Note: The dividend info for the St. Augustine cemetery fund is incorrect. It should be: Market Value @ Dec 31, 2018 \$8,828.31. Gain \$68.37. Market Value @ Dec 31, 2019 \$8,897.68.

Maggie Thorsell – where does it show in the book work the money that came in from the friends of St. Augustine? Lois Lohmann - That money was received by CCA and was put in major maintenance and bills were paid out of there. This allowed the donees to receive a tax receipt.

- Pg 50 CTF market values as at Dec 31, 2019. You will see the difference of gains/losses on the 2020 reports. Linda Stanton How many endowments are for a specific reason? Lois Lohmann Three.
- Identifiable givers.
  - In 2019 there were 54 identifiable givers, 36 parishioners and 18 additional donors
  - At the end of 2019, 23 parishioners used EFT (Electronic Funds Transfer) contributing a total of \$28,430 to the Local Offering.
  - To meet the Local Offering target for 2020 of \$55,097, this translates to an average of \$29.43 per family per week.

Joan Bradley - What is the definition of an identifiable giver? Lois Lohmann - It is used in relation to local funds so is specific to those who donate and receive charitable receipts.

• Note: Questions were asked at each point of the financial statement presentation and are included where asked

Motion to receive the 2019 Financial Statements: Barclay Frost. Second Brian Hull. Motion carried. Thank you, Lois!

7. Motion Regarding the Proposal to join the Area Parish of Mississippi Lake Presented/moved by Henry Troup. Seconded by Michelle Kay.

"That the Vestry of Christ Church Ashton agrees to combine with St. James' Franktown, St. John's Innisville and St. James' Carleton Place, becoming a Chapter of the Area Parish of Mississippi Lake, and to develop a shared statement of mission with the other Chapters in the Area Parish, to be presented at the annual Chapter and Vestry meetings in 2021."

Any questions:

Barclay Frost – it says to develop a shared mission statement - did we not already do that? Rev. Mary Ellen - No, the shared statement of mission needs to be developed to determine how we work together to serve missionally the greater area as church. The last meeting discussed specifically priestly services.

Karen Wiggins – at the original meeting, there were 2 options: To become part of Mississippi Lake as our own entity OR to join in an integrated fashion were others would be responsible for the books. Rev. Mary Ellen - There were never 2 options actually, it was always the intention that CCA remain its own entity. Karen Wiggins - So does that independence need to be reflected in the motion? Rev. Mary Ellen - It is covered by the notion of a chapter, which asserts that each church has its own vestry. For information, the other 3 chapters have had the same motion presented at each of their annual vestries where it was passed at all 3. Barclay Frost – who will develop the shared statement of mission? Rev. Mary Ellen – over the course of the year it will probably be the parish councils in conference with the greater parish community. Barclay Frost - Should the motion reflect this? Rev. Mary Ellen - Again, not necessarily. This is the motion that has been used elsewhere and the shared understanding is inherent.

There will be a vote by ballot rather than a show of hands as this lends opportunity for honest input that a show of hands may suppress. 3 Scrutineers: Trilly McKenzie, Gerd Lohmann and Kirk Hansen

The question on the ballot is the same as on Pg 52.

- 8. Presentation of the Budget for 2020 being the version that INCLUDES us being a part of the Area Parish of Mississippi Lake by Lois Lohmann
  - 2020 Budget pg 30. Reviewed prior 3 years to generate 2020 budget.
  - Revenue
    - Total Revenue from Offerings \$64, 347
    - Fund Raising \$11,850
    - Other Income \$9,162 (Please note, budgeting dividend income is a guesswork exercise!)
    - Question: Linda Stanton the penny jar was amazing! Is this included anywhere? Lois Lohmann It is part of the outreach fund and is already paid out.
       Linda Stanton So will the jar still be there? Lois Lohmann Yes and it will continue to be included as outreach.
    - Total Revenue Budget \$85,323

#### Expenses

- Total Church Expenses \$16,393 in particular, savings on printing should be realized in the area parish configuration
- O Diocesan Payments \$60,702 again, savings are being realized here due to the area parish configuration
- Other Expenses \$1,558
  - Question: Brian Hull what is supply ministry? Lois Lohmann when supply priests cover for vacation.
- Rectory Expenses \$6,670 the area parish has requested \$500 to help to cover telephone costs.
  - Comment: Brian Hull part of the money paid to the Diocese covers all the priests of the parish, but we are also contributing to the overhead of the Diocese in general, including community ministries.
- Total Expenses Budget \$85,323

Motion to approve the 2020 Budget: Henry Troup. Second David Thorsell. Motion carried. Again, a particular thank you to Lois for all the time, care & attention that you give to this. And a thank you to Michaela McConnell for the time you too give to being envelope secretary.

9. Appointments & Elections for 2020

Thank you to our outgoing wardens, Henry Troup and Michelle Kay.

Rev. Mary Ellen is pleased to appoint Gerd Lohmann as Rectors Warden. Thank you to Lois Lohmann for agreeing to carry on as Treasurer.

People's Warden: Kirk Hansen has agreed to stand as nominee for this position.

Synod Representatives: Henry Troup has agreed to stand as nominee for this position. There is one other position for election and - by note and Rector preference - one other Synod rep

canonically, is meant to be a warden. Kirk Hansen offered to stand as this nominee. Brian Hull and Jennifer Bulman have agreed to equally share the alternate position.

Council Member's at Large: Bonnie McConnell (as youth representative!) and Jennifer Bulman have agreed to stand as nominees. One other position is vacant to which Janice Hansen offered to stand.

Cemetery Board: Barclay Frost has agreed to stand as nominee for this position.

Any other nominations? None offered.

#### **Slate for elections:**

People's Warden – acclaimed Kirk Hansen.

Synod Representatives – acclaimed Henry Troup & Kirk Hansen.

Synod Alternatives – acclaimed Brian Hull & Jennifer Bulman.

Parish Council Member's at Large – acclaimed Bonnie McConnell, Jennifer Bulman & Janice Hansen.

Cemetery Board – acclaimed Barclay Frost.

Historically there have been deputy wardens at CCA.

Chris McKenzie was nominated by Kirk Hansen, seconded by David Thorsell. Confirmed.

Maggie Thorsell offered a welcome to Rev. Mary Ellen who is no longer our interim priest! (Although her actual title has yet to be determined in the newly enlarged Area Parish of Mississippi Lake.)

#### 10. Other Business

- Brian Hull requested that progress on youth & children's ministry be included in next year's vestry reports.
- Gerd Lohmann Right now the policy for inclusion on the memorial board is receipt of a \$100 donation. Motion by Gerd Lohmann: That any parishioner that was actively supporting CCA can be recognized on the memorial board without any donation requirement. Second Bonnie McConnell. Motion Carried.
- Rev. Mary Ellen has a dilemma in having to leave CCA to be at St. Bede's in time for service which means she cannot regularly participate in fellowship following the 9:30 service at CCA. Two options: Keep the service time at CCA at 9:30 and the status quo OR Move the CCA service time to 9:00am. (Note: St. Bede's has already moved their service time from 9:30 to 11:15.) Maggie Thorsell concern is for seniors who are already challenged in meeting a 9:30 time. Brian Hull what about introducing morning prayer regularly? Jennifer Bulman Is this the right time to make this decision? Rev. Mary Ellen this is not a vestry issue true, but she wanted it to be a collaborative deci-

- sion. Trilly McKenzie & Bonnie McConnell what about using lay leadership alternatively on a rotation? Linda Stanton 9:30 is already a challenge and earlier would make it too easy to not be here for 9:00.
- Kirk Hansen what are we going to do about exterior signage at CCA? Gerd Lohmann This is already in hand.

#### **Incumbents' Reports**

#### **Christ Church Ashton**

The Incumbent's report to Vestry is intended in the Canons, Bylaws and Regulations of our Diocese to be a "report upon [the] condition, progress and needs of the Parish" (R.5.05). I have always found this to be a valuable guide.

The condition of Christ Church Ashton's structures, finances and ministry are good. I think 'good' conditions in the midst of transitioning from one parish model to another, interrupted by a global pandemic, in a day and age when everything around us is changing faster than we can keep up with — well, that's pretty darned good! I can't wait to see the finished product of the renovations. I can't wait to get going on some good stewardship programming. I really can't wait until the vaccines have done their job, and our common life returns to normal. Until then, our Diocesan church will be with us every step of the way. As a part of the Area Parish, Christ Church Ashton has options about how we move forward, options that didn't exist before. We've barely talked about those options, due to the interruption and disruption of COVID-19. Like Noah, the ark of our church waits for the day when the flood waters recede and we make landfall. We carry two of every kind of our traditions of word and sacrament, fundraising activities and outreach ministries, music and proclamation with us, ready to repopulate our community with faith, hope and love.

Progress has necessarily been slow in building a working relationship with the other churches in Mississippi Lake. We have not built the shared statement of vision we intended at the last Vestry meeting in 2020. This has been very frustrating for me, and I suspect for many of you as well. But the energy of our leaders was not wasted! We opened our doors for four months in 2020, which required a major heavy lift on the part of the team tasked ith keeping us safe. I don't think anyone could ask for anything more.

I believe the need right now, other than making sure everyone is aware of the financial needs in the 2021 budget, is to stay the course. We need to rely on those called to serve (clergy, lay leaders and volunteers), and on what we are called to be (a constituent part of an Area Parish, not a standalone congregation). As we said during the discernment that led to last year's Vestry decision, if that doesn't work, we reconsider. There is currently no way of knowing until we get back to normal. We do need to engage in a formal financial stewardship program. This affects all aspects of our common life, not just the amount of money that shows up on the collection plate. The Anglican Church of Canada sponsors a program called Giving our Thanks and Praise. It is built in a very simple oputline of Inspiring, Inviting, and Thanking people for their offering. We've seen good results elsewhere in the parish, and I believe it's the right tool for Christ Church Ashton. As you'll read in the next section, the search for new ministry to take up where the Reverend Rosemary Parker leaves off is going to occupy some time and energy at

the beginning of the year. Perhaps by the second half of 2021, we'll launch some new initiatives. But I won't make predictions – not this year, that's for sure.

#### The Area Parish of Mississippi Lake

As a Parish, we welcomed Christ Church Ashton to Mississippi Lake in March after a process of discernment and vestry decisions. The process of parish-building was then to begin again. It was almost immediately interrupted by the COVID-19 pandemic and suspension of in-person activities. On of the strengths of how Anglicans do church lies is how we are structured. We already shared a strong relationship and bond by being members of the Diocese of Ottawa. The basic unit of church for us is a Diocese, served by a Bishop who sends clergy to local parishes and congregations. Missional responsibility lies in the hands of the local church, but our 'body' is wider and more broadly based, and collectively we are stronger. On the strength of that relationship, as a Diocese we are able to provide for the needs of the local churches and resource that mission. Two full time clergy with one part time associate, a parish administrator, two musicians and proper supports provide for the needs of all in Mississippi Lake. This is so much more than one part-time clergy covering multiple congregations, or one church with not-quite enough to do the work it is called to do.

What we really look forward to, when vaccines have had their effect and pandemic restrictions are behind us, is the opportunity to take full advantage of collaboration. The whole of the Parish of Mississippi Lake can be far greater than the sum of the parts. That will happen, but now is the time to patiently stay the course.

As we turn towards a new year, we say goodbye to the Reverend Rosemary Parker, Associate Incumbent of the Parish of Mississippi Lake. It will feel like there's a piece missing for a while, and we will be missing the essential ministry Reverend Rosemary provided. In due course, a new ministry will come to us. It will not take her place. And while her place will now be somewhere else, her impact on this Area Parish as the first holder of her office will be felt for years to come. We wish her well as we release her to her next assigned position in the church we all serve.

The work of ongoing discernment continues. It's worth taking some time here so that everyone understands how we proceed from this point forward.

#### Canonical Authority

C4.06.1 The appointment of all Clergy to all offices within the jurisdiction of the Diocese of Ottawa shall be vested in the Bishop, but before the appointment of an Incumbent is made to a

Parish, the Bishop shall consult with the Churchwardens and the Lay Members of Synod of that Parish, as a Committee.

Over the next few months, we will engage in a process of determining what particular ministry our parish needs to do the work we are called to do. When the time is right, I will ask the Bishop to send us someone to fill that ministry position. One option is the appointment of another Associate Incumbent. If that's what we need, the appointment will unfold as described above. If another path presents itself and seems right to us, and the Bishop concurs, we could find a part-time priest, deacon or specialized lay ministry is a better way for us to respond to emerging ministry opportunities. The Incumbent and Clergy will not be making decisions alone. This discernment will include leaders from across the parish, listening carefully to the needs of our people and the places in which we are called to serve.

Given the current restrictions on in-person activity, there is no advantage to rushing to discernment. In the meantime, an interim priest will be assigned to us to make sure we don't overwhelm the clergy and lay leaders here.
